

Privacy Policy

This Privacy Policy was updated on September 12, 2023.

When you use Rhymers Ridge, LLC's products, services, or website (collectively, "RR"), we understand that you are trusting us with some of your personal and sensitive information. We take this responsibility seriously and work hard to protect your personal information.

We have developed this Privacy Policy to help you understand what personal information we collect, how we collect it, why we collect it, and how we use it. **BY USING RR'S WEBSITE, PRODUCTS, OR SERVICES YOU ARE CONSENTING TO THE PRACTICES DESCRIBED IN THIS PRIVACY POLICY SO PLEASE READ THIS CAREFULLY. IF YOU DO NOT CONSENT, DO NOT USE RR'S WEBSITE, PRODUCTS, OR SERVICES.**

This Privacy Policy only applies to information we gather through your use of RR's website, products, or services. It does not apply to the information collected by third-party sites linked on our website such as Instagram, Facebook, Twitter/X, Google Maps, etc., who have their own privacy policies you can review.

What personal information we collect

Personal information is data that can be used to identify a single person. You may be asked to provide your personal information when you are in contact with RR or an affiliate of RR. RR and its affiliates may share this personal information with each other and use it in accordance with this Privacy Policy. RR and its affiliates may use this information to provide and improve our services, content, marketing, and products. We collect personal information that you provide to us on applications, forms, emails, online, and in interviews. In addition, we may receive information resulting from your transactions with any companies with whom we have business relationships. You are not required to provide the personal information requested, however, if you choose not to do so, we may not be able to provide you with certain services, products, or requests.

If you are a potential candidate for employment or a contractor role with RR, we may have received your personal information from third parties such as recruiters or external websites. We will use the personal information we receive to contact you about a potential opportunity or in evaluating your candidacy.

When you leave comments on our site, we collect the data shown in the comments form, along with your IP address and browser user agent string to help spam detection.

If you leave a comment on our site, you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

Articles and pages on this site may include embedded content (e.g. videos, images, articles, etc.). Embedded content from other websites behaves in the exact same way as if the visitor has visited the other website.

These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that embedded content, including tracking your interaction with the embedded content if you have an account and are logged in to that website.

You have the right to see and correct any personal information we may collect about you. If you believe any of the information we have collected about you is erroneous, we would appreciate your assistance in making corrections.

What we do with your personal information

We may use your personal information, such as address or email address, to keep you posted on RR's latest services, products, promotions, or upcoming events. If you do not want to be on our mailing list for these items, you can opt out at any time by sending us a written request.

We may use your personal information for compliance with RR's legal obligations, such as to satisfy a contract to which you are a party, either directly or indirectly, to protect your best interests, or when it is necessary for the purposes of the legitimate interests pursued by RR or a third party to whom it may be necessary to disclose information.

If you apply for a position at RR, or we receive your information in relation to a potential role at RR, we may use your information to evaluate and contact you.

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue. Any comments you make on our site may be checked through an automated spam detection service.

Nonpersonal information collection and uses

We collect certain data in a form that does not, on its own, enable direct association with any specific person. We may collect, use, transfer, and disclose non-personal information for any purpose. For example, we may collect information such as occupation, income, zip code, area code, school district, unique device identifier, referrer URL, location, and time zone where our services, products, or website is accessed so that we can better understand customer behavior and improve our services, products, and advertising.

We may collect information regarding customer activities on our website and aggregate it to analyze which parts of our website, services, and products are of most interest to consumers.

If we do combine non-personal information with personal information the combined information will be treated as personal information for as long as it remains combined.

How we protect your personal information

We use appropriate security measures for data collection, storage, and processing in order to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our website. Do not send any confidential information to RR through unsecured or unencrypted electronic communications and do not share your username and password with anybody, as we cannot be responsible for identity theft from a user's actions.

We do not sell, trade, or rent your personal information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners or trusted affiliates for the purposes outlined above. We may use third party service providers to help us operate our business and the website or administer activities on our behalf, such as sending out newsletters, packets, or surveys. We may share your general information with these third parties for those limited purposes.

If you have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.
